I'm not quite sure what you are asking of us here. I agree that budget scholarship and scrutiny is extremely important for taxpayers and investors, among others. We are not currently a party to any lawsuits over New York's budgeting practices. Our research findings are publicly available and we welcome any and all to use them, with appropriate credit.
