Welcome to an "inside view" of how shamelessly The Times has continued to operate -- POST Jayson Blair.


By the way, I am addressing the priority mail package to the address that was at the bottom of your e-mail:

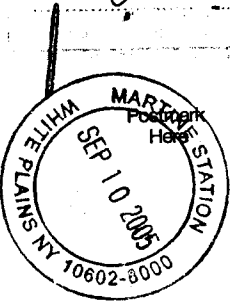
