RE: The federal judicial nomination/confirmation process

Dear Professor Carter:

We are dumfounded and disappointed by your failure to respond to our January 23, 1994 letter enclosing the Ninth Judicial Committee's critique of the federal judicial screening process or to respond to our follow-up phone messages of February 10th and March 8th. Indeed, I have today left an additional message on your telephone answering machine.

We recognize that you are a busy man. However, in view of the extraordinary relevance of our investigative critique to the book you are completing on "the confirmation mess", we would have expected great interest by you and an immediate request for the additional materials described in our January 23rd letter.

For your convenience, a second copy of our January 23rd letter is enclosed. Inasmuch as our grass-roots citizens' group is completely unfunded, we reiterate the request contained in the last paragraph therein:

"In the event you do not wish to pursue the evidence presented by our critique, its compendium, and the other materials we have enclosed, we would most appreciate your returning same to us."
