

“Inasmuch as the federal judiciary's subversion of the judicial disqualification and disciplinary statutes transcends politics – a fact reflected by CJA's aforesaid letters -- CJA respectfully requests that the Committee's Republican majority invite counsel for the Committee's Democratic minority to participate at next week's meeting – and, if deemed appropriate, that Republican and Democratic counsel from the Senate Judiciary Committee also be invited.
