Dear Mr. Mulhauser:

Following up our phone conversations together on June 5<sup>th</sup> and June 16<sup>th</sup>, this is to formally request the ACLU's assistance in the above-captioned criminal case against me for "disruption of Congress".

The important proposition to be championed in this case -- worthy of the ACLU's advocacy -- is that "a citizen's respectful request to testify at a congressional committee's public hearing is not -- and must never be deemed to be -- 'disruption of Congress'". This is set forth in my June 16<sup>th</sup> memorandum to Ralph Nader, Public Citizen, and Common Cause -- to which the ACLU is an indicated recipient. A copy is enclosed. Although the documents referred to therein are ALL posted on the homepage of CJA's website, including the most immediately important -- my May 21<sup>st</sup> letter to Detective Zimmerman, my May 21<sup>st</sup> letters to Senators Schumer and Clinton, and my May 21<sup>st</sup> and May 28<sup>th</sup> memoranda to Senate Judiciary Committee Chairman Hatch and Ranking Member Leahy -- copies are enclosed for your convenience.

Also enclosed is a memo discussing the "documents underlying the prosecution" and discussing those and other documents, *to wit*, (1) the May 23<sup>rd</sup> "Information" of the

U.S. Attorney for the District of Columbia; (2) the U.S. Attorney's May 23<sup>rd</sup> letter, signed by Assistant U.S. Attorney Leah Belaire; (3) my August 19, 1998 letter to Ms. Belaire, in her then capacity as "Investigative Counsel" for the Senate Judiciary Committee; (4) the May 23<sup>rd</sup> sworn statement of Officer Roderick Jennings; (5) my September 22, 1996 police misconduct complaint, with the responses of Capitol Police and Metropolitan Police<sup>1</sup>; and (6) pages 65-66 of the stenographic transcript of the Senate Judiciary Committee's May 22<sup>nd</sup> "hearing".

My next court date in this matter -- by which time I am expected to have made arrangements for counsel -- is August 20, 2003, at 2:30 p.m. A copy of the court notice is enclosed.

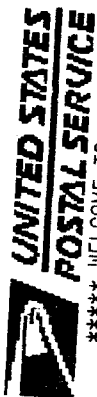

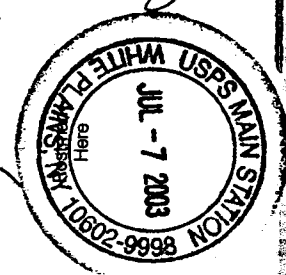
