Attached is my self-explanatory May 4, 2018 message to Lieutenant Governor Candidate Jumaane Williams – to which the Working Families Party is an indicated recipient so that it may respond. CJA's webpage for the message, from which the referred-to EVIDENTIARY PROOF is accessible, is here: http://www.judgewatch.org/web-pages/elections/challengers/jumaane-williams.htm.

Meantime, kindly e-mail me the rules of the Working Family Party and the names of its leadership, including of executive and state committee members and county chairs, with pertinent contact information — as it has not been posted on the Working Families Party website, http://workingfamilies.org/states/new-york/, as suggested by my below January 24, 2018 e-mail, to which I received no response to that suggestion or anything else.

By the way, was my January 24th e-mail, entitled "Transforming the 2018 NYS elections -- & WINNING the races for governor, attorney general, comptroller, & for legislative seats -- with CANDIDATES WHO ARE NOT CORRUPT POSTURERS, for the benefit of ALL New Yorkers", disseminated to the members of the state committee for discussion and determination, including in the context of their vote to endorse Attorney General Schneiderman and Comptroller DiNapoli. And at what meeting was that vote taken? Was it the same April 14, 2018 meeting in Albany at which they voted to endorse Cynthia Nixon for governor and Jumaane Williams for lieutenant governor? Until a short time ago, the Working Family Party website posted only the fact that Schneiderman and DiNapoli had been endorsed, with their names hyperlinked to their campaign websites and no details of the endorsements supplied. Now, in light of Schneiderman's resignation, in disgrace, his endorsement by the Working Families Party, at some point prior to April 24, 2018, has been taken down — without any trace that it had ever been there: http://workingfamilies.org/states/new-york/?sec=endorsements.

What "process", consistent with the Working Families Party's rules and basic vetting procedures, produced the Schneiderman-DiNapoli endorsements, in face of my January 24th e-mail, with its above-attached August 10, 2017 OPEN LETTER? And what are the Working Families Party's specific vetting procedures and standards for endorsements of statewide and state legislative candidates? Is EVIDENTIARILY-PROVEN CORRUPTION IN OFFICE by incumbent public officers NOT disqualifying? And is that why the Working Families Party's questionnaire for applicants seeking endorsement for statewide and state legislative office fails to include any question as to whether, to the applicant's knowledge, he has ever been the subject of a criminal or ethics complaint filed with prosecutorial and disciplinary authorities – and requesting the applicant to sign a waiver to enable the party to procure the relevant records from those authorities? Is that also the reason there is no question as to whether the applicant has been sued in lawsuits relating to his official duties – and requesting details and case records pertinent thereto? And, why, since the statewide and state legislative questionnaire contains no questions raising confidentiality concerns, has the Working

Families Party not posted the completed questionnaires in substantiation of its endorsements. Will you post them – or make them accessible, upon request?

Of course, the Working Families Party's use of the word "endorsements" is a euphemism for its designating candidates to run on its party line. Have the state committee members read Election Law §6-104(6) entitled "Party designation; statewide office", whose explicit time frame they have violated, in letter and spirit, both:

"The meeting of the state committee for the purpose of designating candidates shall be held not earlier than twenty-one days before the first day to sign designating petitions and not later than the first day to sign designating petitions for the primary election."

Isn't the purpose of this provision to ensure the integrity of the electoral process by a publicly-announced time frame, of maximum length, alerting persons contemplating statewide office of their time parameters for coming forward to furnish state committee members with proof of their qualifications so that "The meeting of the state committee for the purpose of designating candidates" can have before it a maximum of such interested, qualified persons from which to choose?

Surely the Working Families Party is advised by Election Law attorneys. What do they say? And what say the members of the Working Families Party's executive committee, state committee, and its county chairs – to whom I request you forward this e-mail, which, for their convenience and yours, will be posted on CJA's webpage for the Working Families Party, here: http://www.judgewatch.org/web-pages/elections/parties/working-families-party.htm. That is where is also posted my January 24th e-mail to which I received no response from the Working Families Party.

To encourage your response, a copy of this e-mail is being sent to the New York State Board of Elections, in support of my oral complaint against the Working Families Party, made yesterday.

Thank you for your return call — and for giving me an opportunity to speak with you at fair length — including by a tour of the Center for Judicial Accountability's webpages for "OUTING CORRUPT AND COLLUSIVE INCUMBENTS and Ending Their Road to Re-Election and Higher Office — WITH EVIDENCE!" — the first prominent center link on our homepage, www.judgewatch.org

There are so many ways in which the New York State Working Families Party can take a leadership role in making the electoral process more accessible and meaningful, both to its own members and to the public at large — among these by a website posting its party rules (as the NYS Green and Reform Parties do) and listing its leadership, executive

committee, and/or county chairs, with pertinent contact info (as the NYS Republican, Conservative, Libertarian, and Green Parties do). That you told me you were unaware of my August 10, 2017 OPEN LETTER pertaining to the Working Families Party endorsement of NYS Senator Latimer in his race for Westchester County Executive, which I had sent via Phillip Leber, your Hudson Region Political Director, with whom I had a LENGTHY phone conversation on August 8, 2017 about the process that had led to the Working Families Party endorsement – followed by, as I recollect, a substantive phone conversation thereafter — underscores the need for posting the names and e-mail addresses for Working Families Party officers so that contact may be more direct.

The August 10, 2017 OPEN LETTER summarizes the explosive significance, in this 2018 election year, of CJA's citizentaxpayer action against Governor Cuomo, Attorney General Schneiderman, Comptroller DiNapoli, and ALL incumbent state Senate and Assembly members, suing them for corruption. As the New York State Working Families Party shares many goals with the New York Progressive Action Network (NYPAN), I urge you to read my January 21, 2018 e-mail to its leadership, entitled "Has Stephanie Miner informed NYPAN that CUOMO CAN EASILY BE DEFEATED -- & WITHOUT MONEY -- by a scandal that will achieve non-partisan, ANTI-CORRUPTION, good-gov't reforms for the benefit of NY's 99%". Below is the chain of e-mails reflecting my proposals to the Green Party and to the Libertarian Party, which I herewith now make to the Working Families Party by the above-subject line, applicable to all, "Transforming the 2018 NYS elections -- & WINNING the races for governor, attorney general, comptroller, & for legislative seats -- with CANDIDATES WHO ARE NOT CORRUPT POSTURERS, for the benefit of ALL New Yorkers". Suffice to say, before the New York State Working Families Party or any party endorses ANY statewide or NYS Senate and Assembly incumbent - or any challenger - the duty it owes its members - and the public at large - is to ensure that he/she is NOT a corrupt posturer. Your today's article "Cuomo Amasses \$30 Million War Chest" states that "the governor's race has been slow to develop". You attribute this to Cuomo's huge funding that "has helped him scare away serious rivals in his bid for a third term" – on top of which are his favorable poll ratings, which you also report. In your words, "The combination of Mr. Cuomo's cash and polling strength has proved daunting for would-be challengers."

'The truth of the matter is, it's very late,' said strategist Susan Del Percio. 'Anyone who is interested, unless they're extremely well-funded, needed to start running a year ago to raise money, get their name out there and raise awareness. And in this current environment, having President Trump in charge will scare away a lot of people - just look at the county executive races in Westchester and Nassau counties.'

We'll see if Cox, by this afternoon, will have some news and some names." (bold in original).
