Following up our phone conversations a short while ago, bravo to Senator Sanders for hosting tomorrow's important event "Attack on Black Leaders: Corruption or Conspiracy?"

Our nonpartisan, nonprofit citizens' organization, Center for Judicial Accountability, Inc. (CJA), has THE EVIDENCE to substantiate that Black and Hispanic leaders have long been disproportionately investigated and prosecuted – and that the REAL corruption of NYS government and the Legislature involves white leaders who have gone "scott free" for their criminal conduct in office.

That EVIDENCE is posted on our website, www.judgewatch.org – and is the subject of a May 7th letter we sent to ALL Senators and Assembly Members, as well as to the press. Entitled "Doing Your Part to End Public Corruption", it identifies that "limited U.S. Attorney resources should not be diverted to snagging Black and Hispanic 'little fish', but to bringing down the big white whales...".

The May 7th letter is attached, for your convenience. It is also posted on our website, on our webpage entitled "Holding Government Accountable for its Grand Larceny of the Public Fisc", accessible *via* our top panel "Latest News". That is where you'll also find our April 15th corruption complaint to U.S. Attorney Preet Bharara against NY's ALL WHITE highest constitutional officers – Governor Cuomo, Attorney General Schneiderman, Comptroller DiNapoli, Senate Majority Leader Skelos, and Assembly Speaker Silver – as well as our April 19th letter to Senator Malcolm Smith – with the substantiating evidentiary proof.

Also attached, FYI, is Senator Ruben Diaz' May 7th mail blast: "*The Only Thing New Is That Blacks and Hispanics Are Being Bugged to Bring Down Their Own*", which had prompted our May 7th letter to the Senators and Assembly Members.

Please forward this e-mail to Senator Sanders, the moderator of tomorrow's debate – as well as to the debating proponents of both the "Corruption" and "Conspiracy" views, so that they may have the benefit of the HARD EVIDENCE summarized by CJA's May 7th and April 19th letters and April 15th corruption complaint. I welcome them to call me with any questions they have.

Needless to say, I will try to personally attend tomorrow's event – and to bring with me the most significant of this EVIDENCE: the verified complaint in *CJA v. Cuomo, et al.*, with its incorporated exhibits.
