RE:	<ol> <li>(1) Status of A.246 (establishing a special commission on compensation of managerial and confidential state employees);</li> <li>(2) Securing legislative oversight of the statute upon which A.246 was modeled: Chapter 567 of the Laws of 2010 (establishing a special commission on judicial compensation)</li> </ol>

This is to alert you that A.246, establishing a special commission on compensation of managerial and confidential state employees, which the Senate passed in the early morning hours of June 21, 2013, following Assembly passage five hours earlier, has <u>not</u> been sent to the Governor for signature.

Once a bill passes both houses, transmittal to the Governor would seem to be a ministerial act. However, we have been unable to ascertain the procedures governing transmittal, other than that it is from the house from which the passed bill originates – which in the case of A.246 is the Assembly.

Please be advised that on June 25, 2013, we sent Governor Cuomo a letter alerting him NOT to sign A.246. The reason:

"because A.246 is the product of a dysfunctional legislative process and is modeled, *verbatim*, on Chapter 567 of the Laws of 2010, establishing a quadrennial special commission on judicial compensation, as to which there has been NO LEGISLATIVE OVERSIGHT. The consequence is that A.246 replicates the constitutional and statutory infirmities of Chapter 567 of the Laws of 2010, itself the product of a dysfunctional legislative process." (June 25, 2013 letter, at p. 1, italics and capitalization in the original).

Indeed, our June 25<sup>th</sup> letter requested the Governor to <u>disapprove A.246 and return it to the</u> <u>Legislature, with his objections</u>, using such return as an opportunity to champion non-partisan, goodgovernment legislative rules reforms essential to ENDING legislative dysfunction.

Please advise as to what steps you will take to secure legislative oversight, analysis, and investigation of Chapter 567 of the Laws of 2010. Or do you believe there should be none, even as its mirror-image A.246 is poised for enactment?
