UNANIMOUS CONSENT AGREEMENT
Vincent L. Briccetti (Cal. No. 45)
John A. Kronstadt (Cal. No. 46)

Ordered, That at 11 a.m. on Tuesday, April 12, 2011, the Senate proceed to executive session to consider the following nominations: Vincent L. Briccetti, of New York, to be United States District Judge for the Southern District of New York, and John A. Kronstadt, of California, to be United States District Judge for the Central District of California; provided further, that there be one hour for debate equally divided in the usual form; that upon the use or yielding back of time, the nomination of Vincent L. Briccetti be confirmed and the Senate proceed to vote without any intervening action or debate on the nomination of John A. Kronstadt; that the motions to reconsider be considered made and laid upon the table with no intervening action or debate; that no further motions be in order to any of the nominations; that the President be immediately notified of the Senate's actions and the Senate resume legislative session.
