Dear Ms. Royle:

Following my phone call to you earlier this afternoon, in which you stated a belief that Journal News Editor & Vice President for News, Henry Freeman, had communicated with me, this is to reiterate that I have received NO response from him or anyone else at The Journal News to my analysis-supported July 14, 2009 letter to you for a retraction of The Journal News' knowingly false and defamatory May 6, 2009 article and for a journalistic expose of the issues of legitimate public concern the article purposefully concealed. The indicated recipients of my July 14, 2009 letter were Assistant Metro Editor D. Scott Faubel, Deputy Managing Editor Bob Fredericks, and reporter Keith Eddings.

Indeed, I also received no response to my faxed, e-mailed, and hand-delivered August 18, 2009 letter to you advising that I had received no response to my July 14, 2009 letter – copies of which I sent to Messrs Faubel, Fredericks, and Eddings.

Copies of both these letters are enclosed.

Voters must be IMMEDIATELY informed of the true facts and important issues suppressed by the May 6, 2009 article so that they can intelligently cast their votes for Mayor & Common council in the upcoming election, now only a week away. Likewise, The Journal News' editorial board must be informed so that its editorial endorsements may alert voters to the flagrant betrayal of public trust and responsibilities by Common Council members seeking re-election and mayoral office.

Please confirm that CJA's correspondence with the Mayor, Common Council & Corporation Counsel, annexed to my July 14, 2009 letter as Exhibits B, C, D, E, & F, will be IMMEDIATELY brought to the attention of The Journal News' editorial board and reporters and columnists handling election coverage, whose identifies I additionally request.

As in the past, I and CJA's President & Co-Founder, Doris L. Sassower, are ready to assist The Journal News in discharging its First Amendment obligations to the public. For your convenience, CJA's website, www.judgewatch.org, posts the relevant primary-source documents, accessible via the top panel "Latest News", featuring a heading "Welcoming Sunshine!", linking to a webpage for "The Corrupt Judicial Appointment Process to White Plains City Court".

Dear Ms. Royle:

This follows up my yesterday's phone conversation with Assistant Metro Editor D. Scott Faubel, who stated to me that The Journal News does not currently have a "Readers' Representative" and that you had designated him to follow-up on my complaint concerning the Journal News' May 6, 2009 article by reporter Keith Eddings entitled "*Hecklers try to derail new city judge*" (newspaper version) and "*White Plains woman heckles city judge during confirmation*" (website version).

Mr. Faubel conceded that his boss is Deputy Managing Editor Bob Fredericks. Inasmuch as my complaint of defamation and cover-up involves Mr. Fredericks – who had direct knowledge of the improper and scurrilous article Mr. Eddings was writing, while he was writing it — I trust you would agree that the complaint should be handled by someone having more distance and independence from Mr. Fredericks. Indeed, as soon as Mr. Faubel's examines my May 5th e-mails to Mr. Fredericks – recapping my May 5th phone conversation with him about Mr. Eddings' then-being-written article – he will doubtless ask to be relieved of having to pass judgment on the actions and inactions of his superior.

My May 5th e-mails to Mr. Fredericks, which I simultaneously sent to Mr. Eddings, are annexed as Exhibit G to my accompanying analysis of Mr. Eddings' May 6th article.¹ Their importance is such that they are reproduced, in full, in the "Introduction" to the analysis, prefaced as follows:

"The three e-mails are herein reproduced, as they underscore the knowing and deliberate defamation that Mr. Eddings and his editor, Mr. Fredericks, intended by The Journal News' May 6, 2009 article and their wilful cover-up of issues of legitimate public concern: the misfeasance, nonfeasance, and malfeasance of the executive and legislative branches of our White Plains City government, undermining its judicial branch with corrupt judges who use their judicial power for ulterior, retaliatory purposes." (at p. 2).

Any impartial review of these e-mails and the analysis will confirm the necessity of oversight and remedial action by The Journal News. This would include retraction of the May 6th article, as well as a journalistic expose of the primary-source documentary evidence of the corruption of the judicial appointment process by which White Plains gets its City Court judges – this being the issue of legitimate public concern the article purposefully concealed.

I and CJA's President and Co-Founder, Doris L. Sassower, would be pleased to meet with you and your designees so as to amicably resolve The Journal News' knowing and deliberate defamation of each of us and blackballing of our non-partisan, non-profit citizens' organization – part of its longstanding pattern and practice of journalistic fraud, withholding from the public issues of legitimate public concern in violation of its First Amendment responsibilities, which we can also amply document.
