## TO: Appellate Division, 3<sup>rd</sup> Department Court Attorney Jane Landes

As discussed over the past several weeks – and now fully drafted – attached is appellants' order to show cause with moving affidavit which, if convenient for the Court, I will be presenting on Tuesday, July 24<sup>th</sup>, for oral argument on the TRO.

I will await your advice as to what changes, if any, must be made as to form. Other than that, I anticipate there will be only minor revisions and pertinent updating in what I will be presenting to the Court.

In view of the serious and substantial nature of what is involved, both on the appeal and by the order to show cause, I am cc'ing, in addition to Assistant Solicitor General Frederick Brodie and his immediate supervisor Assistant Solicitor General Victor Paladino, Attorney General Underwood and her high-ranking supervisory/managerial attorneys so that they can ensure that their own interests and the <u>divergent</u> "interest of the state" are properly represented. It is my position, recited in my moving affidavit, that Attorney General Underwood herself should be present at the oral argument of the TRO – "or some top-ranking deputy, designated by her" – and by this e-mail I hereby give reiterated NOTICE.
