Following up my phone conversation with Regina, at about 1:45 this afternoon, pertaining to appellants' appeal, currently scheduled for oral argument on November 13th, kindly call me, at your earliest convenience -- if not today, then on Monday, November 5th, regarding the three questions I discussed with her:

- the identity of the justices, constituting the appellate panel or, if their identities are not available until November 5th, as Chief Motion Attorney Carey advised me on October 23rd, the time on November 5th when that information will be available;
- (2) permission for a videographer to video the November 13th oral argument this being the same videographer as videoed the August 2nd oral argument, before Justice Devine, of the TRO sought by appellants' July 25th order to show cause;
- (3) the procedure for adjourning the November 13th oral argument, so as to enable the appellate panel to adjudicate the <u>threshold</u> issue of appellants' entitlement to an order striking the attorney general's respondents' brief and declaring the attorney general's appellate representation of respondents unlawful which I sought to have expeditiously addressed by an order to show cause that Justice Aarons declined to sign on October 22nd, thereby necessitating that I proceed by notice of motion, returnable on November 13th. Attached is the full motion, as well as notice of motion, transmitted to both the attorney general and the Court by my below October 23rd e-mail. Also attached is my affidavit of service attesting to my mailed service on the attorney general on October 23rd, as well. As discussed with Julianne, with whom I spoke before speaking with Regina, I will now mail the original affidavit of service to the Court, along with the original notice of motion which I had planned to send up with the reply papers I will be preparing to the attorney general's answering papers, due on November 6th.

As I have written this, I have just received, by e-mail, the attorney general's answering papers, by Assistant Solicitor General Brodie, which I have not yet read. I will do so expeditiously – and will presumably have completed same by the time we speak.
