On April 30, 2018, Senator Liz Krueger introduced, into the Senate, Bill/Concurrent Resolution #S-8309, proposing to amend the New York State Constitution by adding a new Article V-A, whose purpose was "to replace JCOPE and the LEC with a single, truly independent, enforcement agency, similar to the Commission on Judicial Conduct established in Article VI of the State Constitution, to deter corruption in the legislative and executive branches of state government." It was referred to the Senate Judiciary Committee and, on May 18, 2018, referred to the Attorney General for opinion. On June 8, 2018, the opinion was referred to the Senate Judiciary Committee.

On May 10, 2018, the identical bill/concurrent resolution, #A-10651, was introduced, into the Assembly, by Assemblyman Robert Carroll, Esq. It was referred to the Assembly Committee on Governmental Operations and the next day, May 11, 2018, referred to the Attorney General for opinion. On June 7, 2018, the opinion was referred to the Assembly Judiciary Committee.
