Following up our brief phone a short time ago, below is the e-mail chain which, with its above two enclosures, I submitted for the record of the Assembly Judiciary Committee's RIGGED December 1, 2017 hearing on the Judiciary's enacted budget for 2017-2018 – at which neither Ranking Member Montesano nor a single member of the Republican minority was present: http://nystateassembly.granicus.com/MediaPlayer.php?view_id=8&clip_id=4407. Why was that?

Inasmuch as the Judiciary's proposed budget for fiscal year 2018-2019 replicates the fraud and constitutional and statutory violations of the 2017-2018 enacted budget, please advise when Ranking Member Montesano will be available to meet with me to discuss the Judiciary's proposed budget, as well as the other corruption issues within the Assembly Judiciary Committee's jurisdiction that I identified to newly-appointed Assembly Judiciary Committee Chair Dinowitz nearly two months ago by my below October 27, 2017 e-mail, requesting a meeting with him, "as soon as possible".

Needless to say, I would be pleased if Ranking Member Montesano would invite Chair Dinowitz – and other Assembly Judiciary Committee members -- to attend such meeting. Such demonstration of leadership would be consistent with Assemblyman Montesano's December 13, 2017 "Special Message" to his constituents entitled "Knocking Out Corruption": http://nyassembly.gov/write/upload/member_files/015/pdfs/20171213_78561.pdf, portraying himself as a crusader "Fighting corruption in government" – obviously a kick-off for his 2018 re-election campaign.
