Cuomo, et al.* (Albany Co. #1788-2014), that the state-imposed district attorney salary increases, of which he is a beneficiary, are based on judicial salary increases that are statutorily-violative, fraudulent – & unconstitutional – mandating that Genesee County take protective steps.
