#### TO: Dave Rowley, News Director/Chautaugua Today – 1410AM/94.9FM -- WDOE

A pleasure to have spoken with you earlier this afternoon. How ironic that just this morning you hosted a debate between the candidates running for Chautauqua County district attorney – Acting District Attorney Swanson, who has the Democratic, Working Families, Independence, and Women's Equality lines – and Jason Schmidt, running on the Republican, Conservative, and Reform lines.

<u>Assuredly, Acting District Attorney Swanson did not reveal</u> that four months ago, our non-partisan, non-profit citizens' organization, Center for Judicial Accountability, Inc. (CJA), put him on notice of the EVIDENCE establishing that the D.A. salary increases which, since 2012, have jacked up D.A. salaries throughout the state by approximately \$50,000 a year, are fraudulent, statutorily-violative, and unconstitutional – and that his duty to the People of Chautauqua was to make findings of fact and conclusions of law with respect to that EVIDENCE and, based thereon, to repudiate the increases and advise the Chautauqua County government to take appropriate steps to void them.

Chautauqua County voters need to know what Acting Chautauqua County D.A. Swanson did upon receipt of that notice, furnished him by correspondence dated July 1, 2016 and July 8, 2016. What were his findings of fact and conclusions of law with respect to the EVIDENCE particularized therein and readily-verifiable from CJA's website, <u>www.judgewatch.org</u>? (see July 12, 2016 e-mail attached). And what is his response to the October 14, 2016 conflict-of-interest/misconduct complaint that CJA has filed against him and his fellow district attorneys, with New York State's attorney disciplinary committees, for their larcenous pocketing of these salary increases?

CJA's October 14, 2016 conflict-of-interest/misconduct complaint furnishes all the particulars and, with the underlying correspondence and EVIDENCE on which it is based, is easily accessed *via* our prominent homepage link: "NO PAY RAISES FOR NEW YORK'S CORRUPT PUBLIC OFFICERS: The Money Belongs to their Victims!". This brings up a menu of entries, including #12 "Making the 2016 District Attorney Elections Competitive", with a link to the complaint. <u>As for would-be Chautauqua District Attorney Schmidt</u>, what salary does he expect to be paid should Chautauqua voters elect him as district attorney? Is he going to disavow the fraudulent, statutorily-violative, and unconstitutional \$50,000 salary increases of which he would otherwise be the beneficiary and will he be advising Chautauqua County government to take appropriate steps to void them? As a lawyer, he can easily make findings of fact and conclusions of law with respect to the SAME evidence as was before Acting District Attorney Swanson.

Indeed, let both Acting D.A. Swanson and would-be D.A. Schmidt come forward with findings of fact and conclusions with respect to the 6<sup>th</sup>, 7<sup>th</sup>, 8<sup>th</sup>, and 10<sup>th</sup> causes of action of CJA's pending citizen-taxpayer action, *CJA v. Cuomo, et al.* (Albany Co. #5122-16): <u>http://www.judgewatch.org/web-pages/searching-nys/budget/citizen-taxpayer-action/2016/menu-2nd-citizen-taxpayer-action.htm</u> -- referred to at page 7 of the October 14, 2016 conflict-of-interest/misconduct complaint as in a posture of SUMMARY JUDGMENT for the plaintiffs.

Then, too, let each of them state his answer to the question: "If elected, what would your procedures be for handling public corruption complaints, filed with your Chautauqua County district attorney office, where you have financial and other conflicts of interest?"

Any district attorney candidate who will not respond to such straight-forward question pertaining to conflicts-ofinterest – and to the evidence presented by the pending citizen-taxpayer action and October 14, 2016 conflict-ofinterest/misconduct complaint-- must be deemed UNFIT for so important a public office – or any other.

I am available to assist you and your ace reporters to the max, including over the weekend and at night, and will happily answer all questions so that <u>Chautauqua Today</u> can take the lead on this game-changing, corruption-busting story, with ramifications on all 13 of New York State's other district attorney races and all 213 of its state senate and assembly seats.

Following up our conversation a short time ago – for which I thank you – below is the TIME-SENSITIVE, POLITICALLY-EXPLOSIVE election story that your mighty competitor, the <u>Albany Times-Union</u> – has been sitting on for nearly 10 days now. Indeed, I have received NO response to my below October 24<sup>th</sup> e-mail inquiring as to its status, sent to its ENTIRE "Capitol Confidential" reporting team.

In one fell swoop, this story enables the <u>Daily Gazette</u> to examine the uncontested district attorney race not only in Albany County, but in Fulton County – and, additionally, to raise questions as to what each of their highly-paid district attorneys did – and what the highly-paid district attorneys in Montgomery, Saratoga, Schenectady, and Schoharie counties did – upon receipt of my correspondence to them of their duty to repudiate district attorney salary increases that rest on commission reports that are violative of the penal law – being not just statutorily-violative, but fraudulent.

The ramifications of this story go way beyond the district attorneys in the six counties the <u>Daily Gazette</u> covers – and as to those counties extends to their county attorneys, county legislative boards, county executive officers, and county treasurers/comptrollers. Was it the subject of ANY legislative board meeting, discussion, vote? Where are their findings of fact and conclusions of law with respect to the EVIDENCE, laid out for them by the July 8, 2016 letter-notice. How have they protected the counties' taxpayers from outright larceny of the public fisc?
