As you know, the December 10, 2018 Report of the Committee on Legislative and Executive Compensation preserved your stipends in recognition of the "significantly more work" and "additional duties" you are expected to perform (at p. 19). That Report is a fraud on the People of the State of New York and larceny of their tax dollars — and the particulars are set forth by the above-attached analysis of the Report.

Below is the e-mail I sent yesterday to Temporary Senate President Stewart-Cousins and Assembly Speaker Heastie, with the analysis and its accompanying letter-NOTICE. It is now sent to you so that you can demonstrate how you discharge the greater responsibilities for which you are paid. Presumably, this includes alerting the other 57 Senate members and 141 Assembly members to matters of seriousness and substance involving them. In any event, I request that you promptly forward this e-mail to them, with its above-attached July 15, 2019 letter-NOTICE and analysis and below e-mail, each addressed to ALL 63 Senate and 150 Assembly Members.

This is to give you NOTICE of what you should already know: that the December 10, 2018 Report of the Committee on Legislative & Executive Compensation that boosted your salaries is a <u>fraud</u> upon the People of the State of New York – and a <u>larceny</u> of their tax dollars.

To assist you in belatedly discharging your responsibilities to protect the People you were elected to serve, attached is the Center for Judicial Accountability's formal NOTICE to you, transmitting an analysis of the December 10, 2018 Report. Four hard copies, with the exhibits to the analysis, will be sent, priority-mail:

- (1) to the Governor, for himself and the Lieutenant Governor;
