Dear Ms. Bernstein:

Thanks for your prompt return call.

Enclosed is a copy of our April 18th letter to the Senate Judiciary Committee, which we sent, as well, to the Governor's Pataki's office and Senate Majority Leader Bruno--among others.

Our letter describes your excellent piece, "Pataki's Secrets" (p. 1, the last paragraph) and annexes a copy of it as Exhibit "C".

It is our hope that you will follow-up with an expose about how the Governor has "privatized" his selection of judges so as to make it virtually impossible for the public to know anything about or to contribute to the selection of <u>our</u> judges.

You may be interested to know that last January 24th <u>New York Law</u> <u>Journal</u> published a Letter to the Editor from us "No Justification for Process's Secrecy" on the subject of Mayor Giuliani's behind-closed-doors judicial selection. (copy to be sent by mail). That sham process is "open"--by comparison to what the Governor has been doing with more powerful judgeships.

Our April 18th letter to the Senate Judiciary Committee is an attempt to <u>open</u> the process--by challenging Judge Juanita Bing Newton to publicly account for the <u>dispositive</u> evidence that the Commission on Judicial Conduct, on which she sits as a member, is not just dysfunctional, but corrupt. (See p. 3).

As to that <u>dispositive</u> evidence, it is succinctly described by our August 14, 1995 Letter to the Editor, "Commission Abandons Investigative Mandate", also published in the <u>New York Law</u> <u>Journal</u>--which is Exhibit "D" to our April 18th letter.

In the context of the enormous public interest about the Commission on Judicial Conduct--generated by Governor Pataki's referral to it of Judge Duckman--and the Commission's imminently-expected determination--this is not only a <u>dynamite</u> story, but an extraordinarily opportune one (quite apart from "Law Day"--May 1st).
