Dear Mr. Lorson:

Enclosed herewith for distribution to each of the Justices are nine copies of the Center for Judicial Accountability's November 6, 1998 memorandum transmitting the petition for rehearing to the recipients designated by petitioner's October 30, 1998 certificate of service -- including the House Judiciary Committee. The memorandum expressly requests that the House Judiciary Committee deem the memorandum and the rehearing petition:

"an impeachment complaint against the Justices, individually and collectively -- and, particularly, should the Justices continue to disregard their constitutional, statutory, and ethical duty by denying the rehearing petition." (at p. 3)

A copy of the memorandum has been mailed to the New York State Attorney General, counsel to respondents and himself a respondent.

Finally, and as page 3 of the memorandum points out, Exhibit "B" to petitioner's October 14, 1998 judicial misconduct complaint against the Justices (pp. 121-123 of the 1993 Report of the National Commission on Judicial Discipline and Removal pertaining to the Supreme Court) was inadvertently omitted from the appendix to the petition for rehearing. It is annexed as Exhibit "B" to the memorandum.
