RE: My June 7th letter to Solicitor General Preeta D. Bansal, requesting her mandatory supervisory review of the *readily-verifiable* official misconduct of her staff in connection with the Respondent's Brief in *Elena Ruth Sassower, Coordinator of the Center for Judicial Accountability, Inc., acting pro bono publico, against Commission on Judicial Conduct of the State of New York (NY Co. #108551/99) September 2001 Term*

Dear Mr. Belohlavek:

This responds to your June 14th letter. You do NOT identify that my June 7th letter -- to which you refer -- was NOT addressed to you. Rather, it was addressed to your boss, Solicitor General Preeta D. Bansal, and called upon her to *personally* discharge her mandatory supervisory duties under 22 NYCRR §1200.5. This, because of *your* demonstrated refusal to discharge your own mandatory supervisory duties over Assistant Solicitor General Carol Fischer in connection with her fraudulent Respondent's Brief.

Your June 14th letter only reinforces the necessity that Solicitor General Bansal discharge her supervisory duties, *personally*. Thus, it is WITHOUT denying or disputing the accuracy of ANY aspect of my "extensive critique of Ms. Fischer's brief", showing that, from beginning to end, it is fashioned on knowing and deliberate falsification, distortion, and omission of the material facts and applicable law, that you nonetheless assert "we have no intention of withdrawing Ms. Fischer's brief".

Conspicuously, your June 14th letter does *not* identify that Solicitor General Bansal is part of the "we" who will not be withdrawing Ms. Fischer's Respondent's Brief -- and fails to even indicate that she is a recipient of your letter.

Consequently, I am sending a copy of your letter along with my own to Solicitor General Bansal. Just as she *personally* left a voice mail message for me on June 12th, seeming to promise that she *herself* would be undertaking the requested supervisory review, I hereby advise Solicitor General Bansal that I yet await her signed response to my June 7th letter so as to indisputably evidence that fact.

Meantime, enclosed is a stipulation extending my time to file my Reply Brief until August 17th - to which your June 14th letter states "we are willing to consent". Please sign it and fax/mail it back so that I may file it with the Court.
