Shortly after 2:00 p.m. today, I telephoned the Appellate Division, First Department's Motion Clerk, Ron Uzenski, and learned that there had been no response from the Court to my November 13, 2001 letter for its *sua sponte* adjournment of the November 21st oral argument in my appeal pending adjudication of my threshold August 17th motion. Copies of that November 13th letter, faxed two days ago to Deputy Solicitor General Belohlavek and to the Commission, are faxed herewith for your convenience, along with the fax receipts.

Consequently, I will be presenting an interim relief application to the Court at 2:00 p.m. tomorrow, November 16th, to adjourn the oral argument pending adjudication of the threshold August 17th motion.

Although the final paragraph of my November 13th letter requested that Deputy Solicitor General Belohlavek advise me whether he would consent to such interim relief application, I have heard nothing from him. Therefore, please advise, *without delay*, whether you will consent thereto and, if not, whether you will send a representative to meet me at the Clerk's Office at 2 p.m. tomorrow to oppose it. In view of the ample legal resources of the Attorney General's Office and Commission, such representative should be prepared to justify such opposition with legal authority.
