On January 13, 1997 I mailed you via Certified Mail #P-541-851-878, an original and three copies of a judicial misconduct complaint against the Honorable Associate Justice Anthony Kennedy to be docketed in this Court. Those were once again returned to me by Ms. Rapp. As I have stated previously, I believe Ms. Rapp's duties here were strictly ministerial and that she had no choice but to transmit those applications to Justice Kennedy, which she obviously has failed so to do.

I believe you owe me an explanation regarding the status of the 372(c) complaint against Justice Kennedy and also as to the seemingly inappropriate actions of Ms. Rapp.
