Dear Messrs. Asadourian and Finnan:

On September 16, 2005, I made a discovery decision in this case and Mr. Asadourian was to do an order memorializing that decision. The Defendant was to provide documents requested by the Plaintiff at the Defendant's deposition on May 17, 2005 within 30 days. The Defendant was to pay the past due real property taxes on the Keene property within 30 days. This order was made notwithstanding that both the motion and cross-motion were untimely served; the parties seemed agreeable to these two requests for relief. All other relief requested in the motion and cross-motion was denied. It may be that the discovery has been provided and the taxes paid, but an order is still appropriate, if not required.

I want to get this case settled or tried in early 2006. However, I do not have a note of issue which would allow me to set a trial date. If discovery is complete, someone should file a note of issue and Mr. Asadourian must submit a proposed order by January 10, 2006.
