Dear Mr. Levy:

Your November 4th article, "*Philip Morris Gifts to a Pataki Sponsor Are Investigated*", states that the New York State Ethics Commission has initiated an investigation "*in response to articles in The New York Times* in September and October...", which were distributed to the Ethics Commissioners at their recent meeting.

Is there much surprise that the Ethics Commission – whose misfeasance and nonfeasance were particularized by CJA's March 26, 1999 ethics complaint (in your possession for the past two months) was propelled to initiate an investigation based on your series of articles, crowned by a <u>Times</u>' editorial, "Governor Pataki's Friends" (10/16/99)? Indeed, such investigation poses little threat for the Governor-indebted Commission since Governor Pataki professes "that he and his aides knew nothing about... the backers" of the Hungarian-American Chamber of Commerce – a fact noted by your November 4th, October 11th, and September 28th articles.

That the Ethics Commission is, in fact, continuing to protect Governor Pataki from the CRIMINAL consequences of his official misconduct, may be seen from its ongoing NON-RESPONSE to CJA's March 26th ethics complaint. That complaint – more serious than anything in your series of articles -- establishes, by supporting evidentiary proof, the Governor's *direct knowledge and complicity* in: (1) subverting the Ethics Commission, including by his appointment of Paul Shechtman to the Ethics Commission, first as a member and then as its chairman; (2) corrupting the process of state judicial appointments, including the "merit selection" process to the New York Court of Appeals; and (3) covering up the corruption of the New York State Commission on Judicial Conduct.

The Ethics Commission's NON-RESPONSE to the March 26th complaint is particularized by CJA's September 15, 1999 supplement thereto, which I identified to you in my telephone call to you on September 29th – the day after your article, "*Tobacco Giant Gave to Backer of Pataki* Trip", appeared¹. A copy of the September 15th supplement is enclosed. The Commission's NON-RESPONSE to it is detailed in CJA's subsequent complaint, dated October 27, 1999, a copy of which is also enclosed.

It must be noted that at the SAME "recent meeting" of the Ethics Commission at which the investigation reported by your November 4th article was authorized, CJA's October 27th ethics complaint was on the agenda. More than that, portions were read to the Commissioners by Walter Ayres, the Ethics Commissioners public information office. This, according to Mr. Ayres himself.

Please advise when CJA may transmit to you the evidentiary proof establishing the Governor's knowledge of and participation in the systemic, governmental corruption chronicled by the March 26th complaint. It was long ago duplicated for you in the expectation that once you reviewed the complaint, you would want to examine the substantiating proof for yourself. This, not only to confirm its seriousness, but to follow-up on your August 16th front-page article, "Widening Inquiry on Pataki Donors and Parole Board", pertaining to the U.S. Attorney's corruption investigation of Governor Pataki. Indeed, it was because your August 16th article reported that there was "no evidence that [Governor Pataki] had any involvement in the parole decisions", that CJA transmitted to the U.S. Attorney a copy of the March 26th ethics complaint, WITH the substantiating evidentiary proof of Governor Pataki's knowledge and direct involvement in the corruption of the Ethics Commission, judicial selection, and judicial discipline. As you know, a copy
