By a [January 24, 2024 letter](#), you acknowledged receipt of the [attested-to as true complaint I filed with you on January 19, 2024](#), which had stated:

“Commission on Legislative, Judicial & Executive Compensation rendered a ‘false instrument’ ‘force of law’ December 4, 2023 Report on Judicial Compensation to steal taxpayer money for statutorily-violative, fraudulent & unconstitutional judicial pay raises -- \$34.6 million for FY2024-25 (Legislative/Judiciary Budget Bill #S.8301/A.8801, at pp. 18-19)”

In substantiation, I uploaded [CJA’s January 18, 2024 Opposition Report](#) to the [Commission’s December 4, 2023 Report](#).

I have not heard from you since.

On [November 14, 2024, the Commission rendered another “false instrument” “force of law” Report](#), comparably statutorily-violative, fraudulent and unconstitutional, to steal taxpayer money for salary increases for Executive Law §169 state officers and possibly others, the appropriations for which, for FY2025-26, are unitemized and embedded throughout State Operations Budget Bill #S.3000/A.3000. The [November 14, 2024 Final Report on Legislative and Executive Compensation](#) of the [Commission on Legislative, Judicial and Executive Compensation](#) is a fraud on the People of the State of New York and a grand larceny of taxpayer monies by its salary increases to [Executive Law §169](#) state officers and possibly to others that its manipulations of Executive Law §169, by [a chart](#), enables. This is demonstrated by CJA’s

February 4, 2025 Opposition Report, above-attached and here [linked](#). It is addressed to all of you so that individually and collectively you can discharge your constitutional and oversight responsibilities:

- (1) to void the Commission's "force of law" November 14, 2024 Final Report on Legislative and Executive Compensation because it is statutorily-violative, fraudulent, and unconstitutional, to "claw back" the Executive Law §169 salary increases paid out since January 1, 2025 based thereon, and to strike/reduce appropriations for such increases in the FY2025-2026 state budget;
- (2) to refer the Commission's seven members and their co-conspirators in the Office of Court Administration and Division of the Budget for criminal prosecution based on penal law violations including:

[Penal Law §175.35](#): 'Offering a false instrument for filing in the first degree';

[Penal Law §195](#): 'Official misconduct';

[Penal Law §105.15](#): 'Conspiracy in the second degree';

[Penal Law §20.00](#): 'Criminal liability for conduct of another';

[Penal Law Article 496: 'PUBLIC TRUST ACT'](#)

[§496.06](#): 'Public corruption';

[§496.05](#): 'Corrupting the government in the first degree'".

- (3) to investigate and rectify the "elephant in the room" HUGE salaries of the SUNY Chancellor and State Education Department Commissioner, *et al.*, arising from abuses of Executive Law §169.3, without oversight by the executive and legislative branches.
