Our “Unequal Justice” webpage posts Azi Paybarah's video of Senator Sanders' May 11th forum “Attack on Black Leaders: Corruption or Conspiracy?” from which you can see what took place at that event, NOT revealed by Michael Benjamin in his yesterday's City & State column “*Minorities Should Seek Answers, Not Excuses, for Corruption*”, even in face of May 14th & May 17th e-mails that I sent him as to their significance, also posted.

To enable Mr. Benjamin to respond to what his column did not reveal – and to respond to the request presented by CJA's May 22nd letter to ALL Senators & Assembly members for legislative follow-up to Senator Sanders' May 11th forum as to the evidentiary significance of our April 15th corruption complaint in establishing invidious & selection investigation & prosecution – including by a hearing of the 48-member Black, Puerto Rican, Hispanic, & Asian Legislative Caucus -- this e-mail is also being forwarded to him.
