## TO: Professor Grant Reeher/Director of the Campbell Public Affairs Institute at Syracuse University

Thank you for giving me the opportunity to pick up on where we left off, in our first conversation, nearly a year ago, pertaining to the 2009 Temporary Senate Committee on Rules and Administration Reform. As I recollect, you were kind enough to have called me back, promptly, upon receiving my message at that time—albeit you were then in transit, I believe, at an airport. My apologies for failing to follow up, including as minimally as sending you the link to CJA's website, <a href="https://www.judgewatch.org">www.judgewatch.org</a>.

As you could see from what I showed you today, CJA's website furnishes a goldmine of primary-source evidence for scholarship & to inform your media comment & Campbell conversations. As discussed, your most recent Campbell conversation: <a href="http://wrvo.org/post/state-sen-dave-valesky-campbell-conversations-0">http://wrvo.org/post/state-sen-dave-valesky-campbell-conversations-0</a>, was with Senator Valesky, the lead Democratic co-chair of the 2009 Temporary Senate Committee on Rules and Administration Reform, before whom you testified at its first February 6, 2009 hearing in Syracuse. It was my discovery of that conversation, this morning, including about the state budget, that especially prompted my call to you. From these RULES REFORM RESOURCE WEBPAGES, you can access the 2004, 2006, and 2008 Brennan Center Reports – underlying the 2009 establishment of the Temporary Senate Committee on Rules and Administration Reform – and all related primary-source materials I was able find. I highly recommend that you make it a priority to watch the

Committee's third hearing, on February 26, 2009, in Manhattan – including because it was there that Senator Valesky remarked upon the importance of the budget – and Jeremy Creelan identified that one of the legitimate criticisms of the Brennan Center's original report was that it did not specifically address the budget:

rectified in its subsequent two reports.

Did the Brennan Center not know that the New York State budget was "OFF THE CONSTITUTIONAL RAILS"? Below is my self-explanatory March 29, 2018 e-mail to the press – also sent to Cynthia Nixon's campaign treasurer, Professor Zephyr Teachout. Its four attachments are above – the first of which are constitutional provisions relevant to the budget – Article VII, Sections 1-7, and Article III, Sec. 10. The fourth attachment is CJA's August 10, 2017 OPEN LETTER, summarizing the significance of CJA's citizen-taxpayer actions to the 2018 elections – and such is further summarized and demonstrated by the e-mail chain beneath the March 29<sup>th</sup> e-mail.

I look forward to speaking to you again. Call me, at your convenience, hopefully soon -- as time is of the essence, both with respect to constitutional governance and the 2018 elections.
