Dear Mr. Berger:

As Chairman of the New York State Commission on Judicial Conduct -- and the first presenter at the City Bar's public hearing tomorrow -- we call upon you to respond to the enclosed, our May 5th letter to, among others, the New York State Commission on Judicial Conduct.

We specifically draw your attention to the penultimate paragraph which reads:

"By this letter, we call upon you to defend -- if you can -- the record of your wilful inaction, as established by our correspondence with you, which we intend to fully present at the hearing. We specifically invite your testimony about CJA's challenge to the Commission's self-promulgated rule, 22 NYCRR §7000.3, *as written and as applied*, and your rebuttal to our analysis that the court's dismissal decision is a fraud."

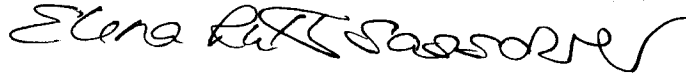
Likewise, we call upon Gerald Stern, the Commission's Administrator and the final presenter at the public hearing, to give his personal response thereto.

Additionally, we note that Juanita Bing Newton, a former Commission member during the critical period of our Article 78 litigation, who participated in the summary dismissal of several of the facially-meritorious complaints annexed to the Article 78 petition, will be testifying at the hearing.

As you know, last year, we vigorously opposed Judge Newton's reappointment to the New York Court of Claims, based upon her betrayal of the public trust in her tenure as a Commission member. We would greatly appreciate if you or Mr. Stern would make known to her our request herein that she, similarly, give her personal response to our May 5th letter.
