Dear Hon. Judge Kaye

I am a former NYC Correction Officer who was arrested and suspended without pay on December 2, 1997 (indictment #3198-98). My human rights and constitutional rights were violated by Judge William A. Wetzel and A.D.A. Maurice Mathias. On August 25, 1998 I was jailed for 21 days for invoking my constitutional rights and thereby violated under Color of State Law. I have since found out that the Department of Corrections had no legal authority or jurisdiction to make arrests concerning tax matters. I have also filed a civil rights complaint with the State Attorney General, Elliot Spitzer. Currently, I am requesting a federal investigation concerning this matter. I was very disturbed by how citizens' rights are being violated in the courts of New York -- and that you, Judge Kaye haven't the slightest clue as the highest ranking administrative law judge in this City. I am also aware that in my case there was never an arrest warrant that was signed by a judge. This was admitted by Mr. Michael Caruso, Assistant Commissioner/ Correctional Services Unit of the Department of Investigation. *This case is strictly political, executed by Mayor Rudolph Giuliani and ex-attorney general, Dennis Vacco.*

Another point I'd like to make is: where is Judge Mary McGowan Davis who has dismissed four of these cases? I've had the opportunity to observe a trial recently and to discover that these cases are civil and *not criminal*, and that the judge had a problem with these cases.

I served honorably in the United States Air Force. I am a Vietnam veteran. I am determined that I will attain justice. I have never committed a crime. Again, I am demanding a criminal investigation concerning corrupt judges and against the NYC Department of Corrections - DOC. Anytime a judge can sit on the bench and badger individuals to take pleas, something is overwhelmingly criminal -- he/she is violating his/his Canons of Ethics.

Dear Honorable Judge Kaye:

I am a former New York City Correction Officer with over twenty years of law enforcement experience. On December 2, 1997 I was arrested for alleged income tax evasion. I wrote to you on May 13, 1999 pleading for your help with regard to a corrupt judge William A. Wetzel of Part 34 - State Supreme Court, 111 Centre Street, New York City. Judge Wetzel, a Court of Claims judge, sent down to adjudicate these tax cases and did act viciously as the prosecutor in these cases: sent 2 men to jail for 2 counts of income tax violations. However, I have a problem with the disparity in punishment. In fact, I have witnessed several trials. Particularly in Judge Ira Beal's courtroom where he stated during Ms. Marilyn Antoine's trial that "he had a problem with these tax cases coming before him, because he did the very same thing concerning taxes -- claimed 99 --- which is a code for exempt or no tax."

I have been following the recent articles in the New York Daily News on appointed and elected judges. How can you as a so-called administrative law judge ignore corruption and complaints about certain judges who blatantly violate citizens' rights and more importantly, their constitutional rights? Namely, William A. Wetzel, a Court of Claims judge who was sent here from Albany, New York by Governor Pataki and also Rudolph Guiliani.


I have also read an article that was written by Tiffany Clay in an upstate New York newspaper concerning illegal campaign contributions and illegal gambling by Judge William A. Wetzel.

Until my last dying breath I will seek justice. You are just as corrupt. My trial was a complete joke! Two so-called tax experts (1) Virginia Urzi from the Crime Bureau at 80 Maiden Lane couldn't answer expert questions and said she was invited by ADA Maurice Mathias to testify. Unreal. I hope that I will receive some justice on my appeal. However, I have very little faith in the criminal justice system.

I do not believe in you Judge Kaye. You are also a mockery to the so-called judiciary. Mr. Wetzel threw me in jail for a 730 evaluation for basically protecting my inalienable rights. I have witnessed Judge Wetzel telling persons of color, who were orderly, to leave the courtroom. A prominent member of the community also witnessed the antics of Judge Wetzel -- a Mr. Charles Barons. The people of this State of New York are being cheated out of justice. Justice here in New York City is politically-store bought.

Dear Mr. Bey:

I am writing in response to your letter to Chief Judge Kaye dated January 18, 2000 and received in this office on January 24.

As I hope you can understand, Chief Judge Kaye may only exercise her judicial authority in cases that have proceeded through the appellate process and are properly before the Court of Appeals. She may not intervene in matters that are pending before other judges, nor may she comment upon pending litigation.

I regret that you have been dissatisfied with your experience in the New York State courts, and I hope that your case is ultimately resolved to satisfaction of all parties.
