This was then repeated, in further reporting, by YNN "web staff": "Moreland Commission taking heat" — without any identification that the scope would be limited.

Nine days earlier, on October 10<sup>th</sup>, Michelle Breidenbach of the Syracuse Post-Standard, reported that the Commission's "next hearing, scheduled for Oct. 28, is on the topic of enforcement at the board of elections". *DA Fitzpatrick: NYC media would not question independence of corruption panel if they knew him*"
