Dear Mr. Zeidman:

It was a pleasure to have finally had the opportunity to speak with you by phone yesterday. Thank you for giving generously of your time and treating me with such courtesy.

Enclosed is CJA's October 16, 2000 report, copies of which were delivered, on October 17th, to the Governor, Chief Judge, the NYS Commission on Judicial Nomination, and the NYS Commission on Judicial Conduct, in addition to the four bar association recipients. As discussed, the report exposes the Commission on Judicial Nomination's abandonment of "merit selection" principles and the fact that the corruption of the Commission on Judicial Conduct thwarts the very possibility of "merit selection". Should you wish to see the underlying substantiating documentation to which CJA's report refers, I would be pleased to provide it.

Some of this substantiating documentation is already in the Fund's possession: the file of the Article 78 proceeding, Doris L. Sassower v. Commission on Judicial Conduct of the State of New York (NY Co. #95-109141), a copy of which was provided in 1995, and the verified petition in the Article 78 proceeding, Elena Ruth Sassower, Coordinator of the Center for Judicial Accountability, Inc., acting pro bono publico v. Commission on Judicial Conduct of the State of New York (NY Co. #99-108551), a copy of which was delivered on July 11, 2000 under my hand-written coverletter.

For your convenience, a copy of that July 11th coverletter is attached, as it highlights the importance of the verified petition in giving "an <u>inside view</u> of the corruption of not only the NYS Commission on Judicial Conduct, but of the Commission on Judicial Nomination."

As one of the foremost proponents of "merit selection" in this State, it is incumbent upon the Fund to address the serious issues detailed by CJA's October 16, 2000 report – including at the confirmation "hearing" on any appointee the Governor might select from the Commission on Judicial Nomination's facially-violative October 4, 2000 report of recommendees.

I would appreciate if you would call me after you have reviewed CJA's October 16, 2000 report. Otherwise, I will call you late next week so as to answer any questions you might have and have the benefit of your comment.
