By the way, it was AFTER my July 9, 2012 letter to Mr. Kallos that "Citizens for an Effective Constitution" removed its organizational name from its website: <http://effectiveny.org/> . Here's the "About" page of that organization's website today, as accessible from Mr. Kallos' bio, and how it appeared on June 13, 2012.

As time permits, I will provide a further summarizing statement – including with respect to the consequences of what Mr. Kallos did. Suffice to furnish the link: **[HOLDING GOVERNMENT ACCOUNTABLE FOR ITS GRAND LARCENY OF THE PUBLIC FISC & OTHER CORRUPTION](#)** – with its postings of our succession of corruption complaints, the most recent being our July 19, 2013 to the Albany County District Attorney resting on our April 15, 2013 corruption complaint to U.S. Attorney Bharara.

What U.S. Attorney Bharara said, as quoted by our April 15, 2013 complaint, certainly applies to Mr. Kallos and his ilk:

"the deafening silence of the many individuals...who learned of...criminal activity being conducted in the...Capitol and elsewhere, and...said nothing. No one made a call. No one blew the whistle. No one sounded the alarm."
