How disappointing to have received no follow-up from you to my below May 21st e-mail, responding to yours. As stated, "You will win against Assemblyman Dinowitz. He is utterly corrupt."

To prove it – and further assist you – attached is the corruption/grand jury complaint against Assemblyman Dinowitz that I filed with Bronx District Attorney Clark on June 8th. ALL the substantiating EVIDENCE to which it refers is posted on CJA's webpage for the complaint, here: <http://www.judgewatch.org/web-pages/searching-nys/2020-legislative/grand-juries.htm>. It should not take you long to recognize that Assemblyman Dinowitz cannot be re-elected, because he must be indicted and will be convicted. Again, I invite you to call me. If you are a serious candidate, no further time should be wasted. You must use the "bully-pulpit" of your candidacy – and forward the June 8th corruption/grand jury complaint to the press, demand Assemblyman Dinowitz respond -- & call upon Bronx D.A. Clark to expedite her time-table for investigation & the grand jury inquiry & indictments. It takes no money for you to do this – and a relatively minimal expenditure of time.
