Mamdani's Win as NYC Mayor is being Rigged by The New York Times & Other NY Press, Concealing his Corruption as a NYS Assemblyman

Zohran Mamdani's win as NYC mayor is being rigged by The New York Times and other NY press. In tandem with their pervasive anti-Israel slanting and defamations, brainwashing New Yorkers and giving credibility and resonance to Mamdani's anti-Israel, pro-Hamas falsehoods, they are concealing his corruption as a New York State assemblyman.

Mamdani's corruption as a NYS assemblyman, destroying safeguarding constitutional state governance and irreparably injuring the People of New York, involves the NYS budget, his legislative salary, and NY's oversight/"public protection" entities – the EVIDENCE of which The Times and other NY press had months before the June 24th NYC Democratic mayoral primary and continually since. They have reported NOTHING, with knowledge that it is DISPOSITIVE that Mamdani is unfit for any office of public trust and that he must be indicted – and will be convicted.

The result of what The Times and other NY press have been doing – including their incessant reporting of polls and endorsements, rigged by their fraudulent, "fake news" journalism – is that NY's Jewish and pro-Israel communities, among so many others, are dispirited and have been inhibited from mobilizing against him because of the purported inevitability of his electoral victory in November. This is catastrophic, as **Mamdani can EASILY be ousted, virtually instantaneously, by the press doing its job of reporting on the EVIDENCE of his corruption as a NYS assemblyman.** What's more, this same EVIDENCE just as instantaneously clears the field of mayoral contenders Cuomo, Adams, Sliwa, and Walden – and upends NYC's other TOP races for NYC public advocate, for Manhattan borough president, for Manhattan D.A., and for Brooklyn D.A., also being rigged by The Times and other NY press.

This has ALL been documented by the NY-based non-partisan, non-profit citizens' organization, Center for Judicial Accountability, Inc.
