Gentlemen:

1a. The body of my letter of February 3, 1989 to the above, to which there was deliberately no response, was as follows:

"Kindly forward to Hon. Sol Wachtler, Chairman of the Administrative Board of the Unified Court System, at Court of Appeals Hall, 20 Eagle Street, Albany, New York 12207, with a copy to the undersigned, a copy of the 'final accounting', if any, that you 'approved' for Puccini Clothes, Ltd., on October 26, 1988.

I, as well as others, have not been able to find same, as part of the aforementioned Order.

Please also advise the Chairman under whose authority you conduct judicial proceedings in 'non-public' facilities, excluding those who you choose."

b. Unquestionably Hon. SOL WACHTLER, as well as the public, are entitled to know that an appointed referee is operating from a non-public courtroom facility, and that he is entering sham, contrived, and false orders in order to conceal the massive larceny of judicial trust assets.

2a. Where there is a court-receiver appointed, as is Mr. Feltman, in all American jurisdictions, there must be a filed accounting, since the public is entitled to know how the judiciary and their cronies dispose of judicial trust assets.

b. There is no possible way that Feltman can truly account for Puccini's assets in view of the massive larceny and plundering that occurred.

c. Consequently, in conspiratorial concert, with Feltman and others, Referee Donald Diamond, on October 26, 1988, "approved", as a "final account", an accounting that simply does not exist.

3a. Hon. SOL WACHTLER, as Chairman of the Administrative Board for the Unified Court System, as well as the public, are entitled to know that Referee Donald Diamond is employing his office for the larceny of judicial trust assets.

b. Referee Diamond, as well as his co-conspirators-- "the criminals with law degrees" -- after being afforded "due process" by your committee, must suffer the ultimate disciplinary penalty.

4. Since the request to Referee Diamond was extensively distributed to the media, this complaint is similarly being extensively distributed.

5. To expedite a response by Referee Diamond, a copy of this complaint is being sent directly to him.
