PLEASE TAKE NOTICE, that upon the annexed affirmation of GEORGE SASSOWER, Esq., dated the 16<sup>th</sup> day of April, 2012, the letter of [former] Presiding Appellate Division Justice MILTON MOLLEN to [former] Surrogate ERNEST L. SIGNORELLI, dated March 3, 1978, a copy of which he mailed to the GRIEVANCE COMMITTEE, NINTH JUDICIAL DISTRICT and received by it on March 6, 1978, the undersigned will move this Court, on the 11<sup>th</sup> day of May, 2012, at 9:30 o'clock in the forenoon of that day or as soon thereafter as Counsel be heard, at the Courthouse thereof, 45 Monroe Place, in the Borough of Brooklyn, City and State of New York, 11201 summarily vacating all disciplinary proceeding against DORIS L. SASSOWER, Esq., including her suspension, unless [former] Appellate Division Presiding Justice MILTON MOLLEN and Chief Counsel GARY L. CASELLA of the Grievance Committee for the Ninth Judicial District "swear under oath", "affirm under penalty of perjury" or "certify" that the disciplinary proceeding against DORIS L. SASSOWER, Esq. were wholly independent of the actions & activities of her husband and/or former husband, than those disciplinary, including her suspension, shall be deemed to be "null & void", and in the event such "affidavit", "affirmation" and/or "certification" is executed by MILTON MOLLEN or GARY L.
