Dear Sir:

1. Pursuant to the Freedom of Information Act, please advise me of the cost incurred by your department in an unsuccessful attempt to effectuate my capture since March 3, 1989.

I have repeatedly stated that if sent a copy of the Arrest Warrant, I would voluntarily surrender, if such warrant is facially valid.

Instead, your main office and your local offices in New Jersey and the Southern and Eastern District of New York, have expended hundreds of man-hours, as well as many thousands of dollars of taxpayers' monies in a futile attempt to arrest me in White Plains, Manhattan, Long Island, and elsewhere.

With the local "radio hosts", and other media outlets, exhorting, ad nauseam, for more police personnel and greater police expenditures, I am asking them to also communicate with your office so that you can rationally explain, if possible, your modus operandi in this matter.

2. My written and oral offers to voluntarily surrender are numerous, and for media purposes, I here set forth a copy of my letter to you, dated March 8, 1989, which reads, in haec verba, as follows:

"I expect the United States marshals under your jurisdiction to perform their duties properly, economically, and with some sense of propriety.

Where your marshals in Newark, New Jersey, receive a warrant for my arrest, for contempt, on Friday March 3, 1989, and have no reason for believing that I would not appear voluntarily before a local magistrate, if so advised, I expect them to act accordingly.

Instead, without any prior notification, I am informed that two of them travelled from Newark to White Plains, New York, on Monday and Tuesday, March 6 and 7, 1989, came to my daughter's apartment and did not find me there.

On Monday, your marshals came at least two times, kept banging on the door, yelling that they were the 'Police', and to 'open up' -- so that all the neighbors could hear.

On Tuesday, my daughter was home, and she was humiliated by their manner, and total lack of civility.

They, inter alia, refused to show any authority for demanding that she open the door, and would not permit her to first call her attorney, and obtain some legal advice.

The bottom line is that your office spent a great deal of time, effort, and taxpayer monies, and obtained no results. A simple letter or telephone call, however, would have been fruitful in every respect.

3. Notwithstanding the aforementioned letter to you, which received no response, and a number of other similar letters to your local offices in White Plains and New Jersey, also unresponded to, you have continued on a charted course of unlawful conduct by, inter alia, excessive and needless force and expense.

4. I will not keep silent on judicial and prosecutorial corruption, and much of my documented evidence of such criminal conduct has been liberally distributed -- thus making academic any attempt to suppress same.

5a. My intention, to be confirmed by telephone, is to be on Friday, May 19, 1989 at WMCA, 888 Seventh Avenue, New York, N. Y., 10019, at about noon, during the scheduled broadcast of Mr. Barry Gray; and at WABC, 2 Pennsylvania Plaza, New York, N.Y. 10021, at about 3:00 p.m., during the scheduled broadcast of Mr. Bob Grant.

b. At the above locations, at the times set forth, you may effectuate my arrest by producing a copy of the sham warrant of March 3, 1989, or any other warrant that you may have, manifestly issued in an unlawful attempt to silence me.

c. At Runnymede, in June of 1215 -- seven hundred seventy-four (774) years ago -- in the Magna Carta, a promise was made that:

"We will appoint as justiciaries, constables, sheriffs, and bailiffs only such men as know the law of the land and will keep it well."

6. If there is any monetary charge for the above Freedom of Information data, upon advise by return mail, I will promptly remit payment.
