included:

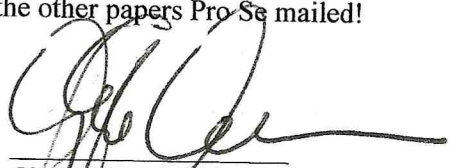
"(C) "directing" the *Pro Se* Office to turn over to Chief U.S. District Court
