RE: Criminal complaints against the New York State Attorney General and his on-going duty as "the People's Lawyer" and under New York's Disciplinary Rules of the Code of Professional Responsibility

Gentlemen:

Enclosed are CJA's October 21st letters: (1) to Andrew Dember, Chief of the Public Corruption Unit of the U.S. Attorney's Office for the Southern District of New York; and (2) to Thomas Wornam, Deputy Chief of the Special Prosecutions Bureau of the Manhattan District Attorney's Office. These letters constitute criminal complaints against the Attorney General for his active complicity in systemic state governmental corruption. This includes, first and foremost, his litigation fraud in defending state judges and the New York State Commission on Judicial Corruption, sued for corruption, and his wilful refusal to investigate evidentiary proof of the corruption of the "merit selection" process in connection with the appointment and confirmation of Appellate Division, Second Department Justice Albert Rosenblatt to the New York Court of Appeals.

Since the massive file evidence substantiating these criminal complaints has long been in the Attorney General's possession, please advise as to what investigative and corrective steps Mr. Spitzer will be taking, consistent with his duty, as "the People's Lawyer", and as head of New York's Department of Law, with supervisory responsibilities under the Disciplinary Rules of the Code of Professional Responsibility to ensure that the litigation conduct of staff attorneys conforms with ethical and legal requirements [22 NYCRR §1200.5 "Responsibilities of a Partner or Supervisory Lawyer", DR1-104].


