This letter encloses my November 4th response to Cynthia Hogan's October 15th letter, as well as her October 15th letter to me.

As highlighted by my response, Ms. Hogan has still not seen fit to telephone us so as to address our specific questions and documentable complaints. Instead, she prefers to waste her time and ours with letters which: (a) make false and misleading claims; and (b) do not address the issues.

Such bizarre and unprofessional conduct by the Senate Judiciary Committee's Staff Director further supports the need--detailed in our October 13th letter to you--for your personal supervision.

We await your response to our October 13th letter--including our request for a meeting with you to discuss the serious matters which our critique and subsequent correspondence have fully documented.

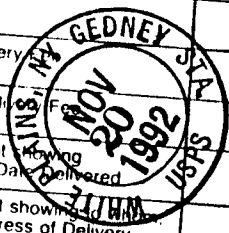
