Dear Senators:

Confirmation of Chief Judge Kaye's reappointment to the NY Court of Appeals must be postponed until the Senate Judiciary Committee has made findings on the documentary evidence, in its possession and

proffered, establishing Chief Judge Kaye's corruption in office, both administratively and judicially. Committee Chairman DeFrancisco's response to this evidence has been to bar testimony about it at tomorrow's confirmation hearing.

We call upon you, as guardians of the public interest, to examine the two written statements furnished to Chairman DeFrancisco so that you can see for yourselves the serious and substantial nature of the testimony and documentary evidence he is withholding from you in making your confirmation decisions. These two statements -- dispositive of Chief Judge Kaye's unfitness -- are posted on the website of our non-partisan, non-profit citizens' organization, Center for Judicial Accountability, Inc.
