As I received no response from you to my below September 17th e-mail – replicating your non-responses to my [years of e-mails to you](#) – I have today filed the above-attached and [here-linked](#) federal complaint, suing you and other NY press for corruption-abetting, election-rigging “journalistic fraud”.

Pursuant to [Rule 4\(d\) of the Federal Rules of Civil Procedure](#), you have “a duty to avoid unnecessary expenses of serving the summons” and I, as plaintiff, may request that you “waive service of [the] summons”, which I am required to do by mail, enclosing a copy of the complaint, two copies of the waiver form and a stamped return envelope.

As a benefit of your timely return of the waiver, you get 60 days from the date of my mailed request within which to answer the complaint, rather than 21 days from the date of physical/personal service – and your waiving service of the summons does not waive any objection to personal jurisdiction or to venue. If, “without good cause”, you fail to sign and return the waiver, “the court must impose” upon you “the expenses later incurred in making service” and “the reasonable expenses, including attorney’s fees, of any motion required to collect expenses”. “‘Good cause’ does not include a belief that the lawsuit is groundless, or that it has been brought in an improper venue, or that the court has no jurisdiction over this matter or over [you]”.

Am I correct that your mailing address is 160 Varick Street, New York, NY 10013, which I was unable to find on your websites, but did locate, for NY Public Radio and WNYC, *via* google searches.

Kindly confirm and also furnish me with the name of your legal counsel and his/her contact information.

I have received no response from you to my September 4th News Tip/Alert, sent to you on that date by my below e-mail – and, then again, because of your block, *via* my personal e-mail. The same is true of the July 25th e-mail I sent you on the same topic, also resent *via* my personal e-mail, due to a block. Why is that? Is there anything that did not check out 100%?

Also, by what process and by whom were you selected to partner with NY1-Spectrum News for three election debates, announced by the NYC Campaign Finance Board on August 26th – and on what terms.

Suffice to say, reporting on the EVIDENCE of Mamdani's corruption as a NYS assemblyman, summarized and furnished by my [September 4th News Tip/Alert](#) and, prior thereto, by my July 25th e-mail, will END him as a mayoral candidate – and Cuomo, Adams, and Sliwa, necessitating cancellation of the October 22nd mayoral debate.
