How disappointing not to have had any response from you to my below October 6th and October 7th e-mails, each furnishing you with drafts of the verified complaint I was intending to file on October 8th in a case so vitally important to Israel and the Jewish community.

The GOOD NEWS, however, is that on October 8th I did file the verified complaint in the US District Court for the Southern District of NY, thereupon e-mailing it to the 25 press defendants. I also e-mailed it to other press entities – and these I have now included as defendants by a verified amended complaint that I plan to file on October 29th. Above-attached and here-linked is the [drafted October 29th amended complaint](#). Upon its being filed, with my payment of the filing fee, I will be issued summons so that I can effect service upon the now 34 defendants, for which I have 90 days.

EVEN MORE GOOD NEWS is that [Shurat HaDin](#), to which I am a contributor, is holding a [conference](#) in Manhattan on Monday, which I will be attending, the purpose of which is to “better unify our activists and our movements, to share individual and organizational information, and to coordinate our strategies for the difficult fights ahead”.

I imagine some of you will be there – and I look forward to discussing the lawsuit with you, at that time, and having the benefit of your comments and suggestions. Certainly, Shurat HaDin and such conference participants as Professor Alan Dershowitz would be interested in your comments and suggestions, as well.

Thank you for the important work you are doing.

This follows up the voice mail message I left yesterday afternoon, which I designated as urgent, and, additionally, the messages I transmitted *via* your [contact webpage](#) and then *via* your [get legal help webpage](#), the latter stating:

“I am director & cofounder of the non-partisan, non-profit citizens organization Center for Judicial Accountability, Inc (CJA) [www.judgewatch.org] -- and, additionally, a Jew, Zionist, lived in Israel for 4 years, and worked at the Israel Mission to the UN for 10 months under Benjamin Netanyahu, who I greatly admire. The NYT & other NY press are dovetailing their anti-Israel animus to election-rig for Mamdani to be NYC's next mayor, concealing his corruption as a NYS assemblyman -- the EVIDENCE of which they have but do not report, notwithstanding it is dispositive that he is unfit for ANY office of public trust & must be indicted and will be convicted. I would like assistance in bringing a federal lawsuit vs the NYT & other NY press for their election-rigging ‘journalistic fraud’ -- the same cause of action as I proposed in my August 19th e-mail to The Jerusalem Post that Prime Minister Netanyahu use for a lawsuit against the NYT for its defamations about Israel and starving babies in Gaza -- the viability of which, under the First Amendment, I tested and proved in two lawsuits, brought in NYS courts, against the NYT and Gannett -- cited to and linked by my August 19th e-mail.” (indicated hyperlinks here made live).

Below, to facilitate your review, is the original August 19th e-mail to The Jerusalem Post, whose relevant paragraph pertaining to Prime Minister Netanyahu and the cause of action for “journalistic fraud” states, in full:

“Finally, kindly forward this e-mail to Caroline Glick, who ‘[formerly held senior editorial roles at The Jerusalem Post](#)’, for transmittal to the prime minister, so that both will know what is going on in NY – and the answer to what the prime minister [publicly stated](#) about The Times’ photos and reporting about starving babies in Gaza: ‘[The] New York Times should be sued...I'm actually looking at whether a country can sue The New York Times, and I'm looking into it right now, because I think it's such a... it's such clear defamation.’ The answer is that irrespective of whether a country can sue, the prime minister can sue, as Israel’s leader and on his own behalf – and such should be not only for defamation, but on causes of action for ‘journalistic fraud’ and “institutional reckless disregard for truth’ – whose viability, proposed by law review articles, I proved by [two landmark lawsuits against The Times and against Gannett](#), never reported by the press or embodied in scholarship.” (live hyperlinks in the original).

I look forward to discussing with you the federal lawsuit I am proposing, as it is one that the NYT and such other NY press as the Israel-reporting Associated Press will NOT survive reputationally or financially, based on the mountain of primary-source, documentary EVIDENCE I have, spanning decades, of their *knowingly* false, corruption-abetting, election-rigging journalism pertaining to NY and US governance – underlying their election-rigging for Mamdani. Such lawsuit would powerfully reinforce and, of course, itself be

reinforced, by a lawsuit by the prime minister against the NYT, *et al.* – which I think is the ONLY way to curtail, dramatically, the endless repetition of brazen falsehoods about Israel that the NYT, AP, and other press put forward, as if not rebutted, resoundingly by fact and law. In that connection, I am sure you are familiar with Law Professor Thane Rosenbaum's scholarly book [Beyond Proportionality: Israel's Just War in Gaza](#), whose release in May seems to have had no effect on their reporting and opinionating – or on Mamdani.

As I believe Professor Rosenbaum has much to contribute to the success of both lawsuits – and because he is already familiar with my below August 19th e-mail to The Jerusalem Post and with my above-attached "ALERT TO NEW YORK'S JEWISH & PRO-ISRAEL COMMUNITIES", which I sent him last night – I am taking the liberty of cc'ing him.

I look forward to discussing the foregoing with you, at your earliest convenience, time being of the essence. I am available, no matter how early or late – and over the weekend.

I am a Jew, Zionist, lived in Israel for four years, and worked for 10 months at the Israel Mission to the UN under Benjamin Netanyahu, who I greatly admire. I am, additionally, director and co-founder of the NY-based nonpartisan, nonprofit citizens' organization [Center for Judicial Accountability, Inc. \(CJA\)](#) – and, [for decades](#), have documented the *knowingly false* journalism of The New York Times and other press pertaining to U.S. governance, specifically relating to judicial selection and discipline on federal and NY state and local levels – essentially paralleling what CAMERA ([Committee for Accuracy in Middle East](#)

[Reporting and Analysis](#)) and [HonestReporting](#) document about how [The Times](#) and other press report and editorialize about Israel.

These two strands of knowingly false journalism, as to Israel and as to NY state and local governance, have led to the rise of Zohran Mamdani to be NYC's next mayor. Mamdani's anti-Israel, pro-Hamas falsehoods have been given credibility and resonance by the pervasive anti-Israel slanting and defamations of [The Times](#) and other NY press, which have, simultaneously, been concealing his corruption as a NYS assemblyman, for which he must be indicted and will be convicted – the EVIDENCE of which they have, but do not report. The result of their flagrant election-rigging for Mamdani – including their propagating of polls rigged by their journalism – is that Jewish and pro-Israel communities, among so many others, are dispirited and inhibited from mobilizing against him because of the purported inevitability of his electoral victory in November. **This is catastrophic, as Mamdani can be defeated, easily and without money, simply by the press doing its job of reporting on the EVIDENCE of his corruption as a NYS assemblyman.**

The Jewish and pro-Israel communities MUST be alerted to what is going on in NY with Mamdani and the NYC mayoral race – and the starting point is my above-attached March 14th e-mail to him entitled “ELECTIONS ARE A TIME OF ACCOUNTABILITY...”, which I e-mailed to [The Times](#) and a substantial portion of NY's press, long before and since his June 24th Democratic primary win. CJA's website posts these e-mails, accessible [here](#) – and among them my below most recent three e-mails to [The Times](#), on [July 11th](#), [July 13th](#), and [August 9th](#), to which – like my predecessor e-mails to [The Times](#) and my [May 18th letter to Publisher A.G. Sulzberger](#) – there has been NO response.

As you were formerly [The Jerusalem Post's “Diaspora affairs correspondent”](#), who is the journalist who has succeeded you in that position – and, if no one, who are [The Jerusalem Post's](#) journalists or news sources on which it relies for this kind of Israel-Diaspora reporting? Will you forward this e-mail to them, ASAP?

When will you be responding to my below July 13th and July 11th e-mails pertaining to Mamdani and the NYC mayoral and other elections?

Are you unaware that notwithstanding my July 13th e-mail highlighted the fraud of The Times' May 28th article "[Mamdani Has a Thin Legislative Record but Is a Forceful Voice in Albany](#)", The Times linked to it in its August 6th article "[Cuomo Tells Business Leaders That His Campaign Is on a New Path](#)", stating:

"Mr. Mamdani, who has a [strong lead in the polls](#), has defended [his record as a state lawmaker](#)..."

Is it your view that the May 28th article accurately depicts Mamdani's "[record as a state lawmaker](#)" and that there is no corruption and larceny in that "record" that The Times was obligated to report and have Mamdani "defend[]" prior to his June 24th primary win? What about now? Isn't it obvious that Mamdani's "[strong lead in the polls](#)" would tumble were The Times to report on his knowing participation in the obliteration of constitutional, lawful state governance, involving the state budget, his own legislative salary, and NY's oversight/"public protection" entities – the EVIDENCE of which I furnished The Times repeatedly before June 24th – and thereafter twice, by my July 11th and July 13th e-mails. Do you deny that such EVIDENCE establishes that **Mamdani cannot be elected NYC mayor, because he must be indicted and will be convicted** – and, so too, Cuomo and Adams, if not, additionally, Sliwa and Walden.

Absent your denying same, The Times' duty is to report on the EVIDENCE, *pronto* – not, as it has been doing, further rigging the NYC mayoral race by misleading the public and business leaders about the situation, including the deceit that “tak[ing] down” Mamdani is difficult, costly, or requires strategic sacrifice by candidates, as by The Times' July 30th article “[‘Anybody but Mamdani’: 5 Groups Emerge to Raise Millions in Attack Funds](#)”, stating:

“with fewer than 100 days to go, [leaders of New York’s business elite] are still very much searching for a unified plan that could work”;

“It remains far from clear if the anti-Mamdani forces can find a successful path, especially when the opposition is divided among several more moderate candidates...”;

“A recent poll paid for by the [Real Estate Board of New York] showed only long-shot paths to victory for Mr. Cuomo and for Mr. Adams... In a city where Democrats outnumber Republicans six to one, those numbers bode poorly for anyone challenging Mr. Mamdani”;

“Three political consultants who have either started independent expenditure groups or have advised donors looking to fund one said they warned donors that the likelihood of defeating Mr. Mamdani is slim unless either the mayor or former governor drops out.” (underlining added)

Then, too, is the article’s misimpression by its unchallenged quote from a Mamdani campaign spokeswoman:

“New Yorkers are ready to turn the page on endless corruption and backroom deals” --

when Mamdani has been part of the “endless corruption and backroom deals” – and this has brought him to where he is today, aided, of course, by The Times' pervasively biased, fraudulent journalism on Israel, making Mamdani’s anti-Israel falsehoods seem legitimate and acceptable.

So that the panoply of Times reporters who have been reporting on Mamdani and the NYC mayoral race can be on notice of the situation and guided accordingly, I am cc’ing them on this e-mail, along with those cc’d by my July 11th and July 13th e-mails.

By the way, when will these, or other Times reporters, be reporting on the record of corruption, *in office*, of top NYC Democratic primary winners [NYS Senator Brad Hoylman-Sigal, running to be Manhattan borough president](#), [NYC Public Advocate Jumaane Williams](#), [Manhattan D.A. Eight hours after sending you my below July 11th e-mail – whose several typos in Mamdani's name I have now corrected – the New York Post published "[Zohran Mamdani's campaign persona called into question by vote to give himself raise: critics](#)", identifying that "Mamdani did not respond to The Post's request for comment."

Apparently, The Post saw "news value" in its July 11th story. Do you? Will The Times be following up by requesting Mamdani's comment to The Post article – the tiniest sliver of Mamdani's hypocrisy and corruption that my below linked March 14th, March 17th, March 18th, and March 20th e-mails to him establish. Have you not yet determined their "news value"?

By the way, is The Times' May 28th article "[Mamdani Has a Thin Legislative Record but Is a Forceful Voice in Albany](#)" the only article The Times published about his record as an assemblyman – so puny that it had to be bolstered by comments from other legislators, ALL Democrats, as to his "forceful voice" "to move the ideological center of the Assembly to the left", interspersed with The Times' usual anti-Israel slanting and slandering, consistent with Mamdani's lies as, for instance, in stating: "Mr. Mamdani stands firm in his defense of Palestinians in Gaza, where over [53,000 people have been killed](#) by Israeli forces" – when revealed by the hyperlink is that this figure is "according to Palestinian health officials, who do not distinguish between civilians and combatants" – in other words, it is according to Hamas.

Suffice to say, this May 28th article, by two of your three Albany reporters – recipients of my March 18th and March 20th e-mails and of my May 18th letter to Publisher Sulzberger – concealed the ENTIRETY of what the e-mails particularized, with evidence, and falsely made it appear as if there is nothing irregular

in how the Legislature operates, including pertaining to the budget and this fiscal year, and the inclusion of policy – indeed, concluding, as follows:

“Perhaps the most telling evidence of Mr. Mamdani’s evolution came earlier this month, when the budget bills came up for a vote. As in years past, they contained scores of policy changes, not all to Mr. Mamdani’s liking. Mr. Mamdani voted yes.”

For that “yes” vote alone, Mamdani cannot be elected NYC’s next mayor, because – based on my e-mails to him – he must be indicted and will be convicted of corruption. [As far back as May 2013](#), I furnished him with the evidence of what was going on, including my [April 15, 2013 complaint to then U.S. Attorney for the Southern District of New York Preet Bharara](#) – sending him e-mail, after e-mail, to which he never responded.
