TO: The Officers Comprising the Leadership & Governance of the New York City Bar Association

This follows my phone conversation yesterday afternoon with General Counsel Lauren Axelrod, reflected by the below, with the above-attached – and my subsequent phone conversation with Board of Directors Chair Devika Kewalramani, with whom I briefly discussed the catastrophic state of affairs that now exists, resulting from decades of nonfeasance and misfeasance by the New York City Bar Association, acting on self-interest, not the public interest, in its advocacy on issues of state governance, untethered to the law or evidence. Among these issues, the Joint Commission on Public Ethics (JCOPE), the state budget, judicial compensation, and judicial and attorney discipline.

To avert the most immediate catastrophe – the replacement of JCOPE with a Commission on Ethics and Lobbying in Government (CELG) that will operate under a markedly <u>inferior</u> statute – I have commenced a combined Article 78 proceeding/declaratory judgment action/citizen-taxpayer action – as to which <u>oral argument on a TRO is scheduled for this Friday, June 17th in Albany Supreme Court</u>. I am requesting the City Bar's intervention, *amicus curiae*, and other assistance, including a lawyer to represent the presently unrepresented corporate petitioner/plaintiff Center for Judicial Accountability, Inc. (CJA). TIME IS OF THE ESSENCE.

The verified petition/complaint, the OSC, and my moving affidavit in support of a preliminary injunction with TRO are accessible *via* NYSCEF, <u>here</u>. I respectfully request that <u>each</u> of you "eyeball" the case so that you will have no doubt as to what the City Bar's ethical, professional, and civic responsibilities are – including IMMEDIATE endorsement of my above June 12th letter to New York's 15 law school deans comprising the "independent review committee" of the "ethics commission reform act of 2022".

As I do not have e-mail addresses for all 25 of the individuals listed on the <u>NYC Bar Association's</u> <u>"Leadership" webpage – these being "Officers & Members of Board of Directors"</u> – I ask that President Susan Kohlmann and Vice Presidents Harlan Levy and Peter J.W. Sherwin ensure that this e-mail is

forwarded to all, including, if they deem appropriate, Vice President Jonathan Lippman, to whom I am not myself sending this e-mail, as his disqualification for interest is direct and absolute.

I am available to answer questions – and would welcome the opportunity to do so.

TO: New York City Bar Association General Counsel Lauren Axelrod

Following up our phone conversation earlier this afternoon (212-382-6600 x6674), I herein reiterate my request that the NYC Bar Association discharge its ethical, professional, and civic responsibilities with respect to CJA's *pro bono*, public interest lawsuit to VOID the "ethics commission reform act of 2022" – as to which, on Friday, June 17th, I will be arguing in support of a TRO before Albany County Supreme Court Justice Peter Lynch. I initially made that request by a June 9th e-mail to Ed Murray, chair of the City Bar's Government Ethics & State Affairs Committee and to former City Bar President Evan Davis, presumably a member of that committee, but acting, as "manager" of a separate Committee to Reform the State Constitution – both part of a "JCOPE Must Go" Coalition. I received no response from either of them or from City Bar Senior Policy Counsel Maria Cilenti, also *cc*'d.

I herein request a written response to that June 9th e-mail – and additionally request that the City Bar endorse my above-attached yesterday's letter to New York's 15 law school deans who comprise the "independent review committee" of the "ethics commission reform act of 2022", re-sent today by the below e-mail. The letter also requests that the 15 law school deans discharge their ethical, professional, and civic responsibilities with respect to the lawsuit and TRO – and, as to the endorsement I here seek from the City Bar, I also request a written response.

I will reserve to a later time recitation of the multitude of serious and substantial conflicts of interest that you, other staff, officers, and members of the City Bar have with respect to my requests herein. Suffice to emphasize, as I did when we spoke, that the City Bar has a posted conflict of interest policy. Observance is mandatory – and violation by a City Bar officer or member is grounds for sanction, including expulsion from the Association, and, with regard to staff, grounds for discharge.

Finally, I again reiterate my request for the names of the members of the Government Ethics & State Affairs Committee that you refused to provide and which, as I stated to you, I have not found identified on any of its reports and testimony, by contrast to the names of the members of the predecessor Committee on Government Ethics, appearing on the last page of the City Bar's March 14, 2014 "Hope for JCOPE" report (p. 64) that the City Bar submitted to the JCOPE/LEC Review Commission in connection with Mr. Davis' testimony before it on October 14, 2015, which was in tandem with that of fellow committee member Daniel Karson.

This follows my phone and e-mail communications with you and/or your offices on Tuesday, Wednesday, and today concerning the lawsuit against you, *Center for Judicial Accountability, Inc., et al. v. New York State Joint Commission on Public Ethics, et al.*, filed in Albany County (#904235-22).

Next Friday, June 17th, at 2 p.m., oral argument will be had, in Albany County Supreme Court at 16 Eagle Street, before Justice Peter Lynch, on petitioners/plaintiffs' request for a TRO to stay the "ethics commission reform act of 2022" – Part QQ of Education, Labor, Housing, and Family Assistance Budget Bill #S.8006-C/A.9006-C – from taking effect on July 8, 2022 and to enjoin JCOPE from closing, pending final determination of the lawsuit's June 6, 2022 verified petition/complaint and its accompanying order to show cause. At issue is the sixth cause of action (¶¶78-85) that Part QQ was enacted unconstitutionally, unlawfully, and by fraud.

On June 17th, I will serve you with hard copies of the papers. In the meantime, you will not be hampered in the slightest in preparing, **fully**, for the oral argument, as all the papers are available electronically, *via* NYSCEF (New York State Courts Electronic Filing). The direct link to the electronic docket of the case is here. Indeed, accessing the case *via* NYSCEF and CJA's website will enable you to access the scores, if not hundreds, of substantiating links petitioners/plaintiffs' papers contain, not accessible from the hard copies.
