Subject Building Scholarship: CJA's Public Interest Lawsuit vs The New York Times in Vindication of the First Amendment

TO: Professor Thomas E. Patterson, Shorenstein Center on Press, Politics, & Public Policy

As discussed earlier today, CJA's historic public interest lawsuit against The New York Times, suing it for journalistic fraud, challenges the notion that a free press "covers what it wants to cover".
