In response to your inquiry what does the number 20244 refer to which is referenced on page 2 of your FOIL request, please be advised that the Statewide Financial System uses unique identifiers called program codes to identify specific appropriations within the system. The number 20244 is the program code for the District Attorney salary appropriation.
