The Senate's Rules, adopted two months ago, at the start of the 2019 Legislative Session, state, in pertinent part, at Rule VI, §1:

“The Temporary President shall refer bills or designate an officer to refer bills to the appropriate standing committee. Bills shall be referred in accordance with a set of guidelines to be published annually by the Temporary President setting forth the respective statutes over which each of the standing committees shall have subject matter jurisdiction for purposes of referral.”
