Thank you for your below July 16, 2019 e-mail, responding to my below July 15, 2019 e-mail, which I sent you because I had been unable to obtain phone numbers and e-mail addresses for counsel's office for Governor Cuomo and an e-mail address for Lieutenant Governor Hochul and for such separate counsel as she might have. Indeed, in addition to telephoning the generic phone number #518-474-8390, published on the Governor's website: <https://www.governor.ny.gov/content/governor-contact-form> – in an unsuccessful attempt, several times, to be transferred to counsel's office, and calling the phone number I had obtained, last year, for Lieutenant Governor Hochul (#518-402-2292) and speaking to an intern, Henry, who had no e-mail addresses to give me, I called the Records Access phone number for the Executive Chamber, #518-408-2302: <https://www.governor.ny.gov/freedom-information-law-foil-requests>, and left a phone message requesting an e-mail address for the Governor's Executive Chamber and for counsel Alfonso David, in particular. I have no record of any call back.

Therefore, pursuant to FOIL (Public Officers Law Article VI), I request publicly-available records identifying a phone number and e-mail address for the office of the Governor's legal counsel and, in particular, for Mr. David or his successor, as I see he announced, in late June, that he would be resigning – and an e-mail address for Lieutenant Governor Hochul, and for such separate counsel as she has.
