This is in response to your Freedom of Information Law request (FL-EM-25/283) for State Education Department records regarding Education Law §801, which was received on March 6, 2025.

Your Freedom of Information Law ("FOIL") request is denied. This FOIL request does not constitute a "request for a record reasonably described" pursuant to Public Officers Law ("POL") §89(3)(a). Specifically, FOIL pertains to existing records only, and it does not compel an agency to answer questions, prepare new records, offer explanations for governmental activities, or perform legal research and answer questions of a legal nature in an effort to be responsive (*see* POL §89[3][a]I and *see also* NYS Comm. on Open Govt. FOIL-AO-9383, FOIL-AO-13208, FOIL-AO-10675, and FOIL-AO-16632a). Therefore, your request is beyond the scope of a request for records made pursuant to Article 6 of the POL.
