Your Chief Counsel Cydney Kelly and your Principal Counsel Eftihia Bourtis have corrupted their offices – and are the subject of a complaint that I have embodied in a request for full Committee reconsideration of their nine fraudulent and Judiciary Law §90.10-violating March 19, 2024 letters, closing, without investigation, a fully-documented [October 25, 2023 complaint](#) against the Monroe County Attorney, five Deputy County Attorneys, and three Attorneys for the Child.

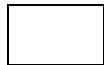
